講義概要 /Course description	Partly inspired by the social movements of the 1960s, environmental history started as a historical inquiry into how human societies have interacted with the natural world over time. Unlike other historical disciplines, it emphasizes the "agency" of nature, or its active roles in influencing human affairs. In short, environmental history examines how humans both shape their environment and are shaped by it. By the beginning of the twenty-first century, most historians shared the notion that neglecting the environment meant missing something important. 	The aim of this course is to help students understand an emerging academic field of environmental history. First, it will briefly introduce how this field

到達目標(授業の目標) /Course objectives	emerged, followed by critical reading of different approaches to environmental history. Then, students will be asked to compare and contrast these methodologies, and to apply one's "ideal approach" to two case studies in regions covering current Mexico, Canada & the United States. After these "practices," students will be asked first to take written exam consisting of ID and essay questions, and then to write a final paper, incorporating primary sources left behind by European explores, missionaries, artists and other observers whose documents reflect particular Euro-centric perspectives.  前半は環境史のモデルを、後半は環境史の事例を米墨・米加国境地帯から検討し、最後には各自が与えられた一次史料(当事者の記録)をもとに環境史を「物語」ってもらいます。
